SECTION B: QUALIFICATION CRITERIA

- The agency must have valid **FSSAI Certificate** as per government norms.
- The agency must have GST No.
- The Vendor should have good experience in proper service of equipments and Neatly Maintained Machineries in the business.

SECTION C: PERMISSION AND LOCATION

- The vending machine shall be installed only at the location approved by the Society Management Committee.

SECTION E: OPERATION AND MAINTENANCE

- Any leakage, odour, pest, or hygiene issue arising from the machine must be addressed immediately.
- Electricity consumption will be borne by the Vendor as per actual usage (through a sub-meter and the Unit rate will be decided by CGMOWA and it will be paid bi-Monthly).
- The machine must operate silently without disturbing residents.
- Demonstrate experience in **operating food vending machines** (preferred).
- Submit a copy of machine brochure/specifications with tender.

SECTION F: PERMISSIONS AND LEGAL COMPLIANCE

- The Vendor must hold a valid FSSAI license, GST registration, and other required local permits.
- The Society shall not be held responsible for any **legal or regulatory** violations by the Vendor.
- The Vendor shall **indemnify** the Society against any penalties, claims, or damages arising out of non-compliance.

SECTION G: SAFETY AND LIABILITY

- The Vendor must have an insurance policy covering damage, product liability, and third-party risks.

SECTION H: COMMERCIAL AND GENERAL TERMS
